# **KEY MATTERS**

• Helped secure a dual victory for two clients accused of patent infringement by developing a bold strategy challenging the validity of the plaintiff's patents. Petitions for *inter partes* review (IPR) of the plaintiff's patents were initiated at the United States Patent and Trademark Office (USPTO), and the USPTO issued comprehensive opinions in the IPRs, rendering all claims in four out of the five patents as unpatentable. The U.S. Court of Appeals for the Federal Circuit upheld the decision, and the fifth patent is currently under IPR at the USPTO.
